

Roxbury Public Library Ebook Reader Circulation Policy

An Ebook Reader is an electronic device used to access digital books, such as an eReader, Nook, or Kindle. Accessories included with the Ebook Reader are 1 Cover/case, 1 Charger/adaptor, and 1 User's Guide.

Checking Out:

- Current cardholders in good standing, 18 years of age or older, can check out an Ebook Reader. The check out limit is one Ebook Reader per patron at any given time.
- The Library reserves the right to refuse service to anyone who abuses equipment or is repeatedly late in returning Ebook Readers.
- The patron will be required to complete an "Ebook Reader Borrowing Agreement" acknowledging acceptance of financial responsibility for lost or damaged equipment. The agreement will remain in effect for all subsequent borrowing periods. Staff will verify that the agreement is on file.
- The patron will need to show a current license or I.D. to validate against patron record.
- Staff will check Ebook Reader for operating condition and completeness in the presence of patron.
- Once an Ebook Reader is checked out to a patron, it becomes the responsibility of that patron.

Use and Loan Period:

- Ebook Readers are checked out for fourteen (14) days with no renewal available.
- The patron should contact the library immediately if there are any problems with the Ebook Reader due to missing parts, technical issues, damage to the Ebook Reader, etc.
- Ebook readers are preloaded with selections made by the Roxbury Public Library. Patrons may not tamper with the Ebook Reader and/or accessories and digital books nor attempt to load digital media or attach any equipment not designed for use with the Ebook Reader.

Checking In:

- Ebook Reader must be returned in person to the Roxbury Public Library during regular library hours. Staff will check-in the Ebook Reader while the patron is present. Ebook Readers MAY NOT be returned to the book drop or to any other library.
- Staff will verify that the Ebook Reader is in operating condition.
- Staff will verify that all Ebook Reader accessories are returned in good condition.

Fees and Liabilities:

- Late return fees for ebook readers are specified in the Fines and Fees Schedule
- Replacement costs for a damaged/lost Ebook Reader and accessories shall be determined by the Roxbury Public Library up to maximums specified in the Fines and Fees Schedule.

- An Ebook Reader overdue 2 weeks will be considered lost, and the borrower will be assessed the replacement cost of the Ebook Reader and accessories.
- The library may use any appropriate means to collect the amount owed for Ebook Reader fees, damages, loss or theft.
- The patron's borrowing privileges will be suspended if an Ebook Reader is returned to the book-drop or any other library.
